2 The internship will be carried out on the basis of the internship program developed by the University.

§ 2

- 1. The workplace undertakes to:
- 1) provide suitable workplaces, rooms, workshops, equipment, tools and materials in accordance with the internship program,
- 2) familiarize students with the company's work rules and regulations, regulations on occupational health and safety and occupational health and safety, as well as the protection of state and official secrets and regulations on the protection of confidentiality of data to the extent specified by the Department of Labor,
- 3) supervise the students' performance of tasks arising from the internship program,
- 4) confirm the provision of care by the persons indicated in §4 paragraph 2 of this agreement in accordance with the provisions of separate agreements concluded between the University and these persons.
- 2. Where the institution is engaged in activities related to the education, recreation, treatment, provision of psychological counseling, spiritual development, sports or the pursuit of other interests by minors, or the care of minors, the Department of Labor also undertakes to: Verification of student information in the Sex Offender Registry,
  - 1) obtain from students information from the National Criminal Register with respect to offenses specified in Chapters XIX and XXV of the Penal Code, in Articles 189 a and 207 of the Penal Code and in the Act on Counteracting Drug Addiction of July 29, 2005, or for

corresponding offenses specified in foreign laws, together with a with a statement that they will submit updated information in the event of a change in the facts, to obtain from students a statement about the country or countries in which students have resided in the last 20 years, other than the Republic of Poland and the country of citizenship in case they have resided in such countries during the aforementioned period,

2) in the case of students who are foreigners and students who have resided in countries other than the Republic of Poland or the country of citizenship, to obtain from students information from the criminal record of the country of citizenship or residence obtained for the purposes of professional or volunteer activities related to contact with children with children, or where the law of the country in question does not provide for the issuance of information for the aforementioned purposes, information from the criminal record of that country, together with a sworn translation, and where the law of the country in question does not provide for the production of such information or there is no criminal record in the country in question obtain from the students a statement to that effect, together with a declaration that they have not been validly convicted in that country of criminal acts corresponding to the offenses specified in Chapters XIX and XXV of the Penal Code, in Articles 189a and 207 of the Penal Code and in the Act of July 29, 2005. on Counteracting Drug Addiction, and no other judgment has been issued against them stating that they have committed such criminal acts, and that they are not obligated by a court judgment, other authorized body or law to comply with a prohibition on occupying any or certain positions, practicing any or certain professions or activities related to the upbringing, education, recreation, treatment, provision of psychological counseling, spiritual development, practice of sports or pursuit of other interests by minors, or the care of minors.
